TERMS & CONDITIONS

- The NST Scholarship is applicable for GATE 2027, ESE+GATE 2027, and ESE+GATE+SES (GS) 2027 Offline Classroom and Live-Online batches only, commencing between 15th December 2025 and 15th May, 2026.
- 2. This scholarship will **NOT** be applicable to any Short-Term Offline/Online Courses, Postal Courses, Test Series etc.
- 3. If a candidate is eligible for any other discount/offer other than NST scholarship, then any one discount, whichever is higher will be applicable.
- 4. The scholarship offered is strictly for the registered candidate only, who has qualified NST and cannot be transferred to any other candidate under any circumstances.
- 5. If the details of any candidate are found to be false or misleading, his/her scholarship will be cancelled immediately.
- 6. During the auditing and result processing, any candidate found involved in malpractice, cheating, or unethical activities during the test will be debarred from the scholarship merit list or subject to suitable action by the MADE EASY Management.
- 7. The scholarship is applicable on the Tuition Fee for Classroom Courses and on the Total Fee for Live-Online Courses.
- 8. Candidates can avail the scholarship for GATE & ESE 2027 Classroom and Live-Online Courses. The enrolled/opted course cannot be transferred to another mode of learning. Example: If a student has taken admission in a Classroom Course, he/she cannot transfer to an Online Course, and vice versa.
- 9. NST Qualified students must produce a copy of their NST Score Card at the time of admission to claim the scholarship.
- 10. Candidates can register and pay the initial fee of Rs. 5,000 + GST on or before 15th December 2025. This registration fee is non-refundable under any circumstances. The balance fee must be deposited on or before the start of the batch.
- 11. An additional discount of Rs. 2,000 will be applicable on tuition fee (over and above the NST Scholarship) will be offered to students who pay the complete course fee in a single installment. This additional discount is valid for NST 2027 qualified students only and will be applicable till 31st December 2025.
- 12. Students wishing to enroll in upcoming batches (not yet announced) **till May 2026** are advised to take admission **on and before 31**st **December 2025**, in the currently announced batches listed on our website. Later, they may visit our admission office to transfer to other suitable batches as per their convenience. Batch transfer charges will be waived off in this scenario.
