## **TERMS & CONDITIONS**

1. The NST scholarship is applicable for GATE 2027, ESE+GATE 2027 & ESE+GATE+SES(GS) 2027 Classroom & Live-Online batches, which are commencing between **1st March 2026 to 31st July 2026**.
2. This scholarship will **NOT** be applicable to any **Short-Term Offline/Online Courses, Postal Courses, or Test Series**.
3. If the candidate is eligible for any discount other than scholarship, then the discount whichever is higher will be applicable. The NST-2 scholarship will not be applicable to students who have already taken admission in the ESE & GATE 2027 Classroom or Live-Online Courses on or before **25th February 2026**.
4. The scholarship offered is strictly for the registered candidate who have qualified NST; and cannot be transferred to other candidate under any circumstances.
5. If the details of any candidate is found fake, then his/her scholarship will be cancelled.
6. During the auditing and processing of the result, those candidates who were found involved in malpractice/cheating/unethical activity during the test are being debarred from the scholarship merit list.
7. Scholarship is applicable on **Tuition Fee** for **Classroom Courses** & on **Total Fee** for **Live-Online Courses**.
8. Candidate can avail the scholarship on GATE & ESE 2027 Classroom & Live-Online Courses. The enrolled/opted course cannot be transferred to different mode of learning. Example: If a student has taken admission in Classroom Course then he/she cannot transfer to Online Course or vice versa.
9. Candidates can register & pay the initial fee of **Rs. 10,000 + GST /-** on and before **15th March 2026**. This Fee is non-refundable in any circumstances. The balance fee should be deposited at the start of the batch. Candidates has to produce the copy of NST SCORE CARD at the time of admission to claim the scholarship.
10. The Validity of the NST Score card is until **31<sup>st</sup> March, 2026**.
11. Students who pay the complete course fee in a single installment will be eligible for an additional discount of **₹3,000** on the **tuition fee**. Please note that this additional one-time payment discount is not applicable to students under Scholarship **Category A (100%)** and **Category B (75%)**. Students may enroll in the announced batches and can later request a transfer to another batch as per their convenience, subject to applicable policies.
12. The decision of MADE EASY management will remain final & abiding to all.
