3. Following is the eligibility criteria:-

- (i) Degree or Diploma in Civil Engineering Discipline.
- (ii) 03 years of working experience in planning/execution/ maintenance of Civil Engineer works as on 11.09.2025 for Diploma holder.
- (iii) Age – Not exceeding 30 years as on 11.09.2025.
(Relaxable in case of Government servant as per instructions/orders issued by Govt. of India from time to time).

4. If you are fulfilling the above eligibility criteria and are willing to be considered by DPCC for the post of Junior Environmental Engineer, you are requested to submit the following information/documents through email within 07 days, so that your candidature may be considered for the aforesaid post:-

(A) List of Documents:-

- (i) Filled up Annexed Information Sheet (attached herewith).
- (ii) Date of Birth as in 10th Class Certificate.
- (iii) Degree or Diploma in Civil Engineering Discipline.
- (iv) Proof of working experience with supporting documents i.e. Pay Slip/Bank Statement etc.
- (v) Aadhaar Card.

5. The shortlisted candidates shall be called to appear in person for verification of above mentioned documents. The selected candidates shall be given the offer of appointment, if found eligible and figuring in the final merit list as per availability of posts. Those accepting the offer of appointment have to mandatorily join within 07 days of issuance of Appointment letter.
