Faridabad Metropolitan Development Authority (FMDA) invites application from eligible candidates, who have qualified/cleared the GATE 2023, 2024 or 2025 Exam as the case may be and who fulfill the eligibility criteria for contractual engagement of experts under FMDA (Engagement of Experts) Regulation, 2020 for the following positions: -

• **Selection Process: -**

- a. The engagement for the aforementioned positions shall be on contract basis for a period of one year **which may be further extended for a period of not more than two years**, depending upon the requirement of the Authority and work performance of the Expert.
- b. The candidates, who fulfil the eligibility conditions of qualification as mentioned above must have qualified the General Aptitude Test in Engineering (GATE), 2023, 2024 or 2025 as the case may be conducted by respective IIT/IISC in the corresponding subject shall only be eligible.
- c. The applicant will fill up the valid score of GATE obtained in GATE 2023, 2024 or 2025 exam (as the case may be) and submit self- attested copy of GATE score card, while applying for the post.
- d. Selection of candidates would be made from the eligible candidates as given in Para 'b' above on the basis of GATE score of the respective discipline. Equal weightage would be given to GATE 2023, 2024 or 2025 Score.
- e. Minimum qualifying cut off marks in respect of GATE 2023, 2024 or 2025 shall be as declared by GATE organizing institute for respective GATE paper/discipline and category of candidate.

- f. The applicant would require to fill up valid score of GATE (Out of 1000) obtained in GATE 2023, 2024 or 2025 exam, whichever is higher, during submission of online form.
- g. In case of GATE score of two or more candidate is equal then candidate older in age would be considered higher in merit. In the case of age also being equal of the candidates with same score, then marks in essential qualifications would be considered for determination of merit.
- h. The shortlisted eligible candidates numbering 2 times of advertised posts would be called for verification/checking of original documents/ certificates in order of Merit prepared on the basis of selection criteria mentioned above. FMDA at its sole discretion may give extended chances to a candidate who due to some genuine constraints could not appear on scheduled date and time fixed for verification of original documents and certificates.
- i. Please note that the engagement of Experts in FMDA is purely contractual in nature. The selected candidates shall have “No claim” to permanent employment that any stage and the Authority reserves the right to terminate the employment as and when the strength of regular staff in FMDA is sufficient.

- **Application Process: -**

Interested applicants must submit their applications **online** at (<https://deployment.setchartron.in/>). The deadline for application submission is 14.02.2026 (23:59 Hrs.). Candidates are encouraged to apply early to avoid last-minute delays.

- Application should give complete detail of the candidate including name, date of birth, residential address, work experience etc. in the Performa.
- Applications will only be accepted through (<https://deployment.setchartron.in/>). No other application methods will be considered.
- Applications along with photograph and signatures of candidates need to be uploaded in the application form at relevant places.

- **Application fee:**

a) **The applicant must pay an application fee of Rs. 500/—plus GST (18%) = Rs. 590/- when submitting the online application form.**

**I. Other terms and conditions:**

- Applications that are incomplete will be rejected without further consideration.
- The applications link will be disabled after the final date. No requests for an extension will be considered.
- Modifications or Additions to the application are not admissible after the online form has been submitted. Hence, candidates should be very careful when filing the application.
- Candidates can apply with a single application. Multiple applications will be automatically rejected.
- Candidates who have obtained degrees/diplomas/certificates from any institution declared fake by University Grants Commission shall not be eligible.  
**Correspondence or part time degrees shall not be considered.**
- Date of issuance of final mark sheet shall be taken as the date of acquisition of the qualification. The candidate must possess the same as on the last date of receipt of the application.
- All educational qualifications must be obtained from a university or institute recognized by the UGC, AICTE or Central and State Governments only.
- The applicant must be under the age of Forty years as on the last date of receipt of the application.
- Any form of canvassing would result in the candidate's disqualification.
- The number of vacancies is purely provisional and may be increased or decreased at the sole discretion of the FMDA.
- FMDA reserves the right not to fill any or all of the advertised positions and to reject any or all applications without providing a reason.
- The remuneration payable to the candidates selected for engagement on contractual basis shall be as mentioned in the table above. The lump sum monthly remuneration shall be inclusive of income tax payable by the candidates. No special pay, compensatory Allowance, Medical Allowance or any other allowance shall be payable and there shall be no annual increment. Persons

appointed on contract basis shall not be eligible for any kind of medical, pension, gratuity or death benefit etc. for the period of such appointment.
